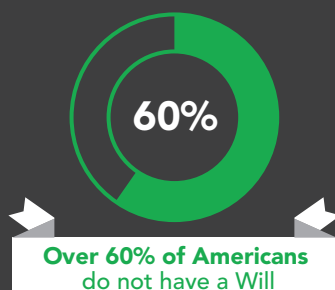
Who will pay your bills, write checks, vote stock, etc. ?
